Course overview

Entry requirements

You will need a minimum level of skills in listening, speaking, reading and writing. The minimum age requirement is 17 years.

All students must obtain a Police Check, statutory declaration, hand hygiene certificate and have proof of vaccinations in order to enter any regulated Aged Care Facility. There may be a requirement to complete an NDIS worker screening check and NDIS Worker Orientation module.

Considerations

May be required to work evenings, weekends and rostered shifts. Required to be physically fit to carry out tasks. Understanding of cultural issues in attending to the needs of individuals.
